4. FY 2000 Budget Instructions

Mr. Welkos reviewed the budget instructions; explained the projected revenues for Fiscal Year 2000; proposed capital projects for public schools, how to handle the available June 30, 1998 fund balance, and pointed out that no specific action can be taken on the fund balance until the completion of the audit. The Commissioners requested additional information relative to the fund balance and a report from the Department of Public Works regarding the importance of moving forward with the slurry seal program (which is one of the projects to be considered from the fund balance).

After discussion Commissioner Chesser moved, seconded by Commissioner Eagan, to sign the Budget Instructions Letter as presented. Motion carried.

In conclusion the Commissioners reiterated their authorization for the County to contract with the County's financial advisor, H. C. Wainwright and Co. to do a Debt Affordability analysis.

METROPOLITAN COMMISSION ANNUAL REPORT

The referenced representatives appeared before the Board to present the Metropolitan Commission's Annual Report for Calendar Year 1997. The report included significant activities

(Compton Area Sewer Extension, which was undertaken as a self-help effort by the neighborhood and resulted in a cost savings of \$223,178; Pine Hill Wastewater Treatment Plant Expansion and Upgrade; Pine Hill Run Flow Equalization Pond; Disaster Management Plan; St. Clements Shores WWTP; Sewer Use/Pre-Treatment Regulation; and Customer Relations Survey); Plans for the Current Year (Route 235/Hollywood Town Center Sewer and Water Project; St. Clements Shores WWTP Upgrade; Wicomico Shores Water and Sewer Projects Phase II and III); Problems and Challenges (Development of comprehensive GIS/GPS system; continued automation; management of shared septic systems; widening of Route 235; Total Maximum Daily Loadings (TMDL's); and Wood Treatment Plant Site). The report also included the following charts: Revenue and Expenses Comparisons; Customer Billings vs. Staff Hires; Growth of Customer Billing; and Customer Survey data.

During discussion Mr. Petty referred to the TMDL's and its impact on development in the community and also showed a video capturing an individual illegally dumping waste in a septic system, and the video helped lead to a conviction.

A copy of the report is on file in the Commissioners' Office.

PUBLIC HEARING HOMESTEAD TAX CREDIT PERCENTAGE

The Commissioners conducted a public hearing on the setting of the Homestead Tax Credit Percentage for St. Mary's County Property Taxes. Mr. Welkos explained that State law requires that counties annually set and report to the State Department of Assessments and Taxation their homestead credit percentage by November 15. If it is not reported, the tax credit percentage would remain at the current rate. The credit percentage is effective for the tax year beginning the following July 1.

St. Mary's County maintained the 10% limit for five years and in FY 1997 reduced the percentage to 5%, which has been maintained since that time.

Action needed is for the Board to enact the homestead property tax credit percentage for the tax year beginning July 1, 1999 (FY 2000).

Mr. Ritchie stated that the Commissioners needed to take into consideration the effect on the taxpayers, stating that if the tax credit remained the same, there will still be an increase in taxes.

Hearing no other comments from the audience, the public hearing was closed. The record will remain open for ten days for written comment.

DEPARTMENT OF PLANNINGAND ZONING ZONING ORDINANCE TEXT AMENDMENTS (DISCUSSION/DECISION)

As a follow up to the September 29, 1998 public hearing, Mr. Grimm presented the following Ordinances:

Ordinance No. Z98-5 – Amending the Zoning Ordinance to add subsection 10.9.2 as follows:

SECTION 10.9 PROHIBITED USES

- 2. Private detention centers and private juvenile detention facilities are prohibited within all zoning districts.
- Ordinance No. Z98-6 Amending the Zoning Ordinance to add the following language:
 - (1) to section 58.3.2.c(1) may be displayed thirty (30) days in advance of the event advertised including signs displayed on barns, trucks, trailers and similar

structures and vehicles; and shall be removed within fifteen (15) days after the event.

(2) and to Section 80.2 DEFINITIONS, the following sentence at the end of the existing definition:

SIGN, PORTABLE – Public service and special event signs as described in Section 58.3.2 are excluded from this definition.

Commissioner Eagan moved, seconded by Commissioner Jarboe, to approve and sign Resolution Nos. Z98-5 and Z98-6 as presented and referenced above. Motion carried.

COUNTY COMMISSIONERS' TIME

Lighting at Wildewood Parkway and Route 4

Commissioner Chesser referred to his request for installation of a street light at Wildewood Parkway and Route 4. An agreement with SMECO regarding the light will be submitted to the Commissioners at a later date for the Board's approval.
