b) Public Works Agreement Addendum for Porto Bello Estates Subdivision located in the Second (2nd) Election District extending the completion date to April 1, 2000. The letter of credit provided by Nations Bank is being reduced from \$202,200 to \$95,000.

LOCAL MANAGEMENT BOARD

The referenced individuals appeared before the Board to provide a briefing on the programs and activities of the Local Management Board. Included in the presentation were the Board's Mission Statement and Values Statement; history and status of LMB's; and the functions and structure of the St. Mary's County LMB.

Areas of discussion included

- LMB's relationship with County Government (that the St. Mary's LMB is quasipublic/non-profit and not a unit of county government so that LMB can apply for private grants and charitable donations).
- Funding source (State of Maryland through Subcabinet for Children, Youth and Families as set forth in the Memorandum of Understanding among the State, County and LMB) and administrative costs (\$100,000/year); The Commissioners requested a copy of the budget and the appendices as referenced in the MOU.
- Space needs (LMB is currently located in the Office on Aging Garvey Center, the space is too small for LMB and OOA will be needing this space)
- Possibility of conflicts of interest (members on board who represent agencies receiving funds). This is being addressed by the LMB.
- Services provided by LMB and the need for interagency coordination in order to avoid duplication of services. This is an issue that will be addressed by the LMB.
- Teen Pregnancy Prevention (The Commissioners requested statistics on this program).
- Goal of getting children returned to the County that have been placed outside the County (LMB has issued an RFP for return services).

In conclusion Ms. Sabella suggested that the County work with LMB on the following:

- To officially recognize the County's relations with LMB (the State requires the Commissioners' approval and signature).
- To join LMB in providing leadership in wellbeing of children and families and make it a priority issue.
- To work with LMB on a future needs assessment.
- To encourage active participation in the work of LMB.
- To assist the LMB in relocating its office.

During his presentation Mr. Erichsen pointed out that there is no turn-around area, and Metropolitan Police Boys and Girls Club officials have agreed to provide an easement, which has been signed by the Club and will be returned to the Board for execution by the County. The County will be responsible for constructing the turn-around.

After discussion among the Board, the Commissioners opened the hearing for comments from the public.

Hearing no comments the public hearing was closed; the record will remain open for ten days for written comment.

Upgrade, Realignment, and Renaming of Private Road "Cheryl Lee Lane" to a public county road – "Colby Drive"

Mr. Crouse displayed a map of the area and described the realignment project.

Areas of discussion included access easements to the Ponder and Brown properties; that there will be no impact on the Ponder and Brown properties, that they will

be able to use the right-of-way, and there will be no costs incurred by them (except for new address signs); and that was a need to clarify language in the draft Ordinance (second paragraph "Board of County Commissioners...has been approached and requested to upgrade..."), because it sounds like the County has been requested to upgrade, when it is the developer's responsibility. (Mr. Erichsen will contact Mr. McCabe to see if the revision can be made.)
