B. Radio Report

We have completed all radio testing, indoor and on street. The requirements of the contract have been met. There are 14 buildings that have met the contract requirements, but need signal enhancement. We are planning this project now.

However, before we sign final acceptance we have requested Harris complete a few more technical issues. The first is preventive maintenance of all mobile and portable radios. This is underway. All of our radios here in Emergency Services are completed. Leonardtown FD has been completed and we are working through the remainder. The plan is to complete this task by December 31, 2018 for all first responder radios. Another task we have asked for is P-25 Phase II capability. This should also be completed by December 31. This will double our radio capacity from 9 talk groups to 18. Why is this important? During the Great Mills High School shooting incident we were very close to capacity of our system. If we go over capacity, users will go into a que and not be able to transmit until someone stops transmitting. P-25 Phase capability is critical important to our operations. There are a few other minor issues we are addressing but that is the most important. Going forward, Harris will attend our ESB meetings and be available to comment on our activities.

Pagers - We are very close to having programming worked out and expect to begin issuing them in the coming weeks. Harris representatives were in attendance and had nothing to add to the report.
