REVIEW/APPROVE MINUTES

Minutes of May 3, 2004 The motion was made by Mr. Baroniak to approve the minutes as written, seconded by Ms. Gardner. The motion carried.

FINANCIAL DISCLOSURE STATEMENTS

<u>Status of 2003 Outstanding</u> It was noted that 246 statements have been mailed. There are two ready for Commission review with 10 outstanding.

Review Session Two financial disclosure statements were reviewed and approved.

Post-Service Filing of FDS Mr. Norris provided a draft copy of the St. Mary's County Government Organizational Chart, showing that some departments and/or positions have been abolished, and other departments have been combined. This will not be finalized until June when the budget is adopted and implemented in July. Consideration needs to be given to whether Division Heads within Departments need to file as they have a great deal of management over many of the day-to-day operations although subject to the approval of the Department Head. Since the reorganization is still a work in progress, the challenge will be keeping the Ordinance updated or providing a mechanism whereby a revision of the Ordinance is not needed but it is recognized that when certain changes happen, the Ordinance still applies. Mr. Norris gave examples of what some other jurisdictions are doing. Mr. Deaderick pointed out that our offer stands to make presentations to groups to enlighten them about the Ethics Ordinance and the rationale behind filing financial disclosure statements. With regard to small-area plans, Mr. Deaderick offered for the Ethics Commission to attend the first meeting of any small-area groups and make a presentation to them on conflicts of interest.

With regard to a letter received from a former staff member indicating there was no change in his financial disclosure statement since filing in 2002, Mr. Deaderick felt we needed to insist that he file another statement. Mr. Deaderick will draft a letter to be sent.

Mr. Norris will keep us up-to-date on the final reorganization of County Government.
