After a review of the Ordinances creating the Senior Property Tax Credit as well as the Committee, it was determined that the Committee will be appointed for one term only (for a period of no more than 30 days), meet during a short period of time and present their recommendations to the Board of County Commissioners. The Committee will not meet again for three years. As a result, the Ethics Commission members determined that the Committee members will only have to file Calendar Year 2006 and 2007 forms. All but one Calendar Year 2006 form was received from the Committee members.

Ethics Training: Mr. Baroniak is working on a draft agenda and introductory remarks for the Ethics training to be held after September 19. It will include representatives from the Ethics Commissions from St. Mary's, Calvert, Charles, and Anne Arundel counties. Ms. Wolfe will prepare a draft table of contents and notebook covers for participant training materials.
