Background

On the 17th Day of December 2013, St. Mary's County Government adopted an ongoing Transportation Advisory Committee to serve in an advisory capacity for planning service and policy changes to St. Mary's Transit Systems services. The committee includes representatives of human service agencies, municipal and county government, private transportation providers, the business community, current customers, and the community at large, including individuals with disabilities.

The Transportation Advisory Committee will provide the Commissioners of St. Mary's County with transit related information and assistance concerning public transportation with respect to preparation of the St. Mary's County Transit Development Plan, Planning of service and policy changes for Locally Operated Transit Systems and coordination among specialized transportation providers. Committee Activities

The Transportation Advisory Committee (TAC), like many other boards and commissions, has suffered setbacks in its efforts to promote transit ridership and other goals by the onset of the COVID-19 Pandemic. The committee has continued efforts in the past year to increase participation and attendance as the effects from the pandemic lessen and a recovery process commenced. Board participation has improved. To increase participation, the TAC moved the location of the meetings to the Chesapeake Building Commissioner's Meeting Room. Utilizing the equipment in the chambers, the meetings are now recorded both aurally/visually and posted to the St Mary's County YouTube channel.

Accomplishments

The TAC continues to increase membership, increase awareness, increase interest in the transit system, and establish relationships with our community partners to further address the transit needs of the residents of St. Mary's County. In CY 2021 the TAC has held four quarterly meetings, moved meeting venues, discussed impacts to Transportation, bus ridership, listened to and discussed the technical and program briefs from ex-officio members.

Problems and Challenges Encountered

Informing the St Mary's County residents of the TAC's activities has been an ongoing struggle. Utilizing the Commissioner's Meeting Room and the recording equipment will help to alleviate some of those challenges. During COVID-19 many of the challenges that faced the TAC were due to the shutdowns/slowdowns caused by the pandemic. The challenge now is how to best advise the public with Transportation issues as ridership increases as St Mary's County returns to normal operations.

Future Plans

The committee will continue to fulfill Article III of the *Bylaws of the Transportation Advisory Committee of St Mary's County*.
