Laura Joyce reported that 14 cases have been reviewed since the last FVCC meeting. They are in the process of developing standards, policies, procedures, etc. for the CRT on the upcoming Tuesday. She will hand out draft once complete.

### Other Business:

Krisanne Bentley from the Commission of Women reported that the play is now required reading in high schools. The play will be presented by CSM at the schools. They are currently trying to find the funding to purchase the script which costs \$1,500. The kick off will be in August.

Laura Joyce initiated a discussion regarding the Mediation Center presentation. There are concerns from some of the FVCC members in regards to the emails between Dr. Kathy O'Brien and the representation from the center. Laura Joyce has been calling other states to find out what they're doing for domestic violence and mediation. She is approximately half way done. She will present the information at the next meeting in September.

Kimberly Gregory informed the council that Lisa Thomas, who strictly handles domestic violence cases, will be introduced at the next meeting.
