**New Members** – Staff reported that V. Govier will continue B. Farrar's term and that a new member will be needed to replace J. Grusholt. The vice-chair position is now vacant.

Bylaws – a review of the bylaws shows that there are discrepancies between those posted on the web and those issued to the commission.

<u>Action item</u>: Staff is to investigate bylaw discrepancies and report back to the commission. In addition, staff will check on the bylaws with the county attorney and investigate the proper procedures for public notice of meetings and report back to this commission.

Minutes- commission would like to reevaluate the minute structure and form. R. Mitchell presented good examples for the structure of the minutes.

<u>Action item</u>: Commission members to come next month prepared to discuss changing minutes form.

<u>Action item</u>: S. Erichsen to produce minutes for the October, November and December meetings.

St. Mary's County Historic Preservation Awards – R. Gibbs recommends the commission begins the process for soliciting awardees for this program.

<u>Motion</u>: Commission to set up a committee of R. Gibbs and S. Erichsen for the Awards program. Motion made by R. Gibbs, seconded by S. Erichsen. Motion carried.

Historic District Commission of Maryland- discussion of what this commission provides.

<u>Action item</u>: Commission to investigate visiting other counties historic preservation commissions and tri-county meetings to investigate what is going on in their communities. <u>Action item</u>: HPC focus on raising awareness of historic preservation in the community.
