#### A. Asset Strategy Portfolio Update - Quarter Ending June 30, 2019.

David Saunders and Ed Boyer presented the update. Discussed the general market changes for the quarter ending June 30, 2019 referencing page three of the LOSAP Quarterly Investment Analysis. It was noted that the portfolio is 100% invested for the last two full quarters. There is no intention to change the asset allocation at this time. This portfolio is more conditioned to perform well when we have a strong down market similar to quarter ended December, 2018. Thus, we expect the portfolio performance to lag a little bit in this strong up market. The asset allocation at the end of the quarter is right on policy. Except for cash which is at 2.1% where

our policy is zero percent. However, the range is zero to ten percent. We will continue to monitor and make changes as needed. We turn to the market value update as of August 28, 2019 and note that the asset allocation has not changed. We turn back to page two to review performance. For the quarter the portfolio is up 2.9%, year-to-date the portfolio is up 11.5% which is a decent return considering we are at 34% allocated to fixed income. We concluded the discussion with we will continue to monitor the process as we cycle through the quarters.
