Call to Order

Carolyn Themie and Debra will be working to design brochures and materials used by the museum.

Debra would like to work on rewording the mission statement as a project for next year.

Millie Huseman reported that she coordinated (with the help of Christina Clagett) a religious pilgrimage of 45 visitors from foreign countries. She would like to see improvements made on the manifest list. In the event of an accident, we would have a problem making notifications to the countries. Suggestion was made to have a pre-manifest list with all the necessary information.

Debra stated that Congressman Hoyer and Delegate John Bohanan along with members of the St. Clement's Hundred Club visited St. Clement's Island. They were impressed with the vision of the replica of the site.

Phil Rollins up-date

- Erosion behind lighthouse- will be working with DNR on interest free loan for next summer
- Small strip of land at PPLHMP along the creek property of approximately .10 acre has been donated to the county
- Myrtle Point Park Nature Park- Harveytown significant historical site. County has adopted master plan for a visitor/nature/heritage center. Several years of interpretative history.

Rose Davis asked that Mr. Rollins express to the County Commissioners and staff our appreciation of the work done at the Piney Point Lighthouse Museum. The building has a very inviting appearance, wonderful gift shop, and great exhibit space.
