### **Old Business**

Extensions of Conditional Approvals

Olde Town Pub – Jason Burroughs- Requesting 90-day extension of conditional approval

Joseph Drury appeared before the Board and was sworn in. A letter was presented allowing Mr. Drury to speak on behalf of the other licensees. Mr. Drury stated that work has started on the renovations of the Olde Town Pub, but they are requesting another 90-day conditional approval to complete the extension of premise. Member Willenborg made a motion for the 90-day conditional approval. Motion was seconded by Member Kohl. Motion carried

Pier 450 – Peggy Binzel- Requesting 90-day extension of conditional approval

Peggy Binzel appeared before the Board and was sworn in. Ms. Binzel stated that the permits for the interior of the restaurant renovations have been obtained and work has progressed. The septic system must be moved so this could take months to complete. Ms. Binzel is requesting a 90-day extension of conditional approval. Member Kohl made a motion for the 90-day conditional approval. Motion was seconded by Member Trossbach. Motion carried.

Special Privilege Application

**Vino 2 – Jaspal Kaur and Gurnam Singh Randhawa-** Requesting a 365-day Beer Wine Tasting Permit

Jaspal Kaur, Gurnam Singh Randhawa and an interpreter appeared before the Board and were sworn in. The interpreter explained that the licensees were requesting to add a 365-day Beer/Wine tasting permit to their license and that the licensees understand the rules they have to follow while having this permit. Member Kohl made a motion for the approval. Motion was seconded by Member Trossbach. Motion carried.

Premise Changes

MIR Beer – Donna Moore- Requesting temporary extension of premise & extra serving counter for Spartan Races on June 29 and 30 from 9:00 AM to 6:00 PM

Donna Moore appeared before the Board and was sworn in. Ms. Moore explained that they are adding Bozick Distributors to the venue this year for the Spartan Race. Attorney Tanavage stated that this would have to be a conditional approval pending the approval from the Health Department. Member Trossbach made a motion for the approval. Motion was seconded by Member Kohl. Member Trossbach made a motion to amend to a conditional approval pending Health Department approval. Motion was seconded by Member Kohl. Motion carried.

**Russell's Store – Janet Draper-** Requesting temporary extension of premise for community wrestling shows on 7/6, 8/4, 9/1 and 10/13 from 5:00 PM to 7:00 PM

Janet Draper and Roger Buckler, Jr. appeared before the Board and were sworn in. Mr. Buckler explained to the Board what happens at this event. Attorney Tanavage reminded the Board and licensee that a Special Events permit will be needed for each individual event. Member Kohl made a motion for a conditional approval. Motion was seconded by Member Trossbach. Motion carried.

**Heavy Hitters Bar & Grill – Tammy Buckler-** Requesting to amend current extension of premises and add an outside serving counter.

Tammy Buckler appeared before the Board and was sworn in. Mrs. Buckler explained that she is requesting to amend the current extension of premise to liberal usage, as she would like to add an extra serving counter to service patrons outside. Mrs. Buckler also was requesting to have live music outside. Mrs. Buckler stated that all alcohol would be securely locked at the end of the evening and remain locked when not in service. Attorney Tanavage stated that all agency approvals would be needed for this approval. Member Willenborg made a motion for the 90-day conditional approval. Motion was seconded by Member Trossbach. Motion carried.

Mr. Shea handed out the information from the CAC conference that was held on June 3, 2019. Mr. Shea explained to the Board about the new Social Host ordinance that the CAC is trying to have put into legislation. The Social Host ordinance would allow St. Maryos County law enforcement to hold individuals responsible for hosting or permitting parties where people under the age of 21 are possessing or consuming alcohol on private property regardless of who supplies the alcohol. A civil and/or criminal citation can be given.
