# Agricultural, Seafood, and Forestry Board March 14, 2013 Meeting Minutes

## Call to Order

The Agricultural, Seafood, and Forestry Board meeting was held in the Conference Room of the Agriculture Services Center. Members in attendance were John Parlett, David Paulk, Adam Dyson, James Moore, Michael Sirk, James Spence, and Joseph Wood. Also present were Tom Koviak from the St. Mary's Soil Conservation District, Ben Beale from the Maryland Cooperative Extension Service and Donna Sasscer and Lisa Ledman from the St. Mary's County's Economic Development Department. Guest attendees included Tucker Brown along with Greg Bowen and Christine Bergmark from the Southern Maryland Agriculture Development Commission. Members not in attendance included Phil Dorsey and James Norris. The meeting was called to order at 12:20 p.m. Attendance was called and it was confirmed that there were enough members present to form a quorum. Minutes from the February 14, 2013 meeting were presented and unanimously approved by the Board.

#### **Old Business**

Agriculture Services Center – Mr. Parlett abstained from any discussion and votes in regards to the Agriculture Services Center. The County's Capital Improvement Projects (CIP) budget has been submitted and at this time the Board of County Commissioners have not expressed any concerns with the request. Ms. Sasscer questioned if it was in the best interests for her office to move to the new building as well – at its current location there is a cohesive economic development "team" yet moving to the Agriculture Services Center would be most convenient to the agriculture community. It was the consensus of the Board that Ms. Sasscer's office should also be relocated to the Agriculture Services Center and a letter to the Director of the Department of Economic and Community Development will be drafted by Mr. David Paulk.

### **New Business**

The Board voted 4 to 1 with 1 abstention to send a letter to the Board of County Commissioners opposing the Proposed Zoning Text Amendment to "Modify Methods for Achieving a Floor Area Ratio Increase". The majority of the Board believes that supporting this measure will undermine the County's Transferrable Development Rights Program.

Dr. Christine Bergmark and Mr. Greg Bowen from the Southern Maryland Agricultural Development Commission (SMADC) briefed the Board on various programs offered by their office. Specific attention was given to the Maryland FarmLINK Mentor Match Program which matches experienced farmers with those younger/newer farmers who would benefit from their knowledge and familiarity.
