#### MORGAN STANLEY

# 1. 2nd Quarter 2017 Investment Performance Review

Jeff Seibel from Morgan Stanley presented the Performance Measurement Report for the period ending June 30, 2017. The Combined Account was up 2.78%, the Domestic Equity Account was up 2.83%, the International Equity Account was up 7.18%, The Fixed Income Account was up 1.50%, The Real Estate Account was up 1.88%, and the Hedge Funds & Private Equity account was down -0.89% for the quarter. The beginning market value of the Plan was \$75,677,658 and the ending market value of the plan was \$78,349,487.

## 2. Tactical Rebalance / Positioning

Jeff Seibel recommended rebalancing of some of the funds to get them more in line with the asset allocation policy. He recommended reducing Templeton Global Bond the rest of the way;

this will close Templeton Global. Morgan Stanley will look for a new fund manager to replace Templeton Global.

Sgt. Shawn Moses made a motion to approve Morgan Stanley's recommendations to rebalance/reposition, seconded by Jeannett Cudmore as follows:
