The board has made a motion to present the new ordinance to County Commissioners concerning permits. This ordinance will require all electrical permits to be issued through the office of Land Use and Growth Management. The Vote was 5-0 in favor. The Electrical Board has reviewed all the other sections of the ordinance and is in agreement. The electrical board met with the County Commissioners and the after a public forum was done the ordinance was passed. All electrical work done in St. Mary's County that does not require a building permit will require a no cost electrical permit. The permit will be obtained through Planning and Zoning. Once the permit is obtained than the electrician can file for an inspection at the inspection agency he uses.
- 3) We are still meeting with SMECO and Harry Knight to work out how the third party inspection will work. This is still a work in progress. The board has reviewed an instruction sheet concerning third party inspections presented by Mr. Harry Knight. The board voted 5-0 in favor of accepting this instruction sheet.
- 4) The County Attorney sent the paperwork to the board to start the process of eliminating the home owners exam. This paperwork will be filled out and submitted to eliminate the exam. The board was in favor of this action by a vote of 5 in favor and 0 opposed. The Board is requesting Mr. Knight to submit the paperwork to start the process of eliminating the homeowners exam.
