Programs at the Maryland Historical Trust. Ms. Ziehl subsequently sent a letter approving the new Agreement between the County and the College and a new Attachment C pursuant to the meeting.

- Scott Strickland Presentation GIS & Archaeology: Applications in Historic Resource Management.

Mr. Strickland had created a power point presentation that took the viewer through the stages of developing the modern GIS and how this mapping helped the Maryland Historical Trust provide an Inventory of data for over 800 sites in St. Mary's County alone. He talked about vector shapefiles; use of patent records to locate project areas; shared several case studies in Leonardtown; settlement modelling and showed draft of Kernel Density of Sites in Relation to the Shore. He talked about site types, including villages, base camps, hamlets, short-term camps, procurement sites and shell middens. He then showed case studies by using site probability models. Mr. Strickland's presentation was the main Agenda Item and he answered questions at the end of his presentation.
