DISCUSSION

Commission Chair Thompson moved the Introduction to an upcoming amendment to the Airport Environs provisions in the Zoning Ordinance to the first item on the Agenda.

1. Introduction to an upcoming amendment to the Airport Environs provisions in the Zoning Ordinance

Presented by: Bill Hunt, Director of Land Use and Growth Management Guest Speakers: Chris Kaselemis, Director Economic Development and John Deatrick, Director, Department Public Works Chris Kaselemis, Director Economic Development introduced discussion and explanation of the Transferable Development Rights (TDR) program.

The following topics of discussion were discussed:

- The County has an in-lieu program where we offer the option to pay an in-lieu fee instead of purchasing Transferable Development Rights (TDR's) on the open market.
- The in-lieu fee above the average transaction price to encourage private sector sales/purchases.
- In-lieu fees collected by the County go towards land preservation. The last time we had an in-lieu fee was FY2009.
- In FY2018 there were only 13 private sector transactions with average prices of \$3,812. The County set the in-lieu fee at \$4,575 to encourage private sector transactions.
- It appears that the new zoning for the Lexington Park Development District Master Plan (LPDDMP) will allow for increased density; however, getting the additional density, developers will have to buy TDRs.
