Commissioner Guy made the motion: In the matter of Concept Site Plan # 17-13200006
Second District Volunteer Fire and Rescue Squad, having accepted the staff report and having made a finding that the Objectives of Section 60.6 of the Comprehensive Zoning Ordinance have been met, and noting that the referenced project has met all requirements for concept approval, I move that the concept site plan be approved.

## **DISCUSSION**

1. Lexington Park Development Master Plan Corrected Land Use Maps - Reapproval

Commissioner Siebert made the motion to rescind the motion that was passed on January 22, 2018, relating to the recommendation to the Commissioners for St. Mary's County the adoption of the Lexington Park Development District Master Plan land use maps dated January 3, 2018.

#### Discussion

Mr. Guy requested an explanation as to why the vote was being rescinded.

Mr. Siebert explained that between the time of the review of the Lexington Park Development District Master Plan and corrections were approved; he purchased property being discussed. The changes made to the property in Great Mills he purchased were not involving changes to land use or zoning. It was a case of the Development District boundary appeared to be shifted and the change was to line up the accurate property lines.

Commissioner Guy seconded. The motion passed unanimously.

2. Lexington Park Development District Master Plan Corrected Land Use Maps - Vote to adopt.

Commissioner Guy made the motion: I move to the recommend adoption of the proposed Lexington Park Developmental District Master Plan land use maps dated January 3, 2018 to the Commissioners of St. Mary's County. With change to parcels 08-179654, 08-179655, 08-179656 Greenwell properties also with the change to parcel 08-031746, HDC Management LLC (Guy Curley). With the change to the Greenwell properties those will be Office and Business Park.

With change to the HDC Management LLC, it will be Split land use, Office Business Park and Residential Low Density.

Commissioner Van Kirk seconded. The motion passed unanimously.
