- Members requested a final copy of the Land Use Maps approved in 2018 by the Commissioners of St. Mary's County.
- Cross out the land that is not LPDD, but allow the original colors and names to show through.
- Request Commissioner King to bring a copy of the Master Plan for Myrtle Point Park from the Recreation and Parks Board.
