Commissioner Guy made the motion in the matter of Concept Site Plan # 17-13200004, Randy Sloan Equipment Storage, having accepted the staff report and having made a finding that the objectives of Section 60.6 of the Comprehensive Zoning Ordinance have been met, and noting that the referenced project has met all requirements for concept approval, I move that the concept site plan be approved. Commissioner VanKirk seconded. The motion passed unanimously.

2. PELBPS LLC Commercial Office Units CWSP Amendment, Case No. 17-200-003

Proposed: Amend service area maps III-34 and IV-34 to change the water and sewer service categories from W-6D (service in 6 to 10 years, developer financed) to W-3D (service in 3 to 5 years, developer financed) and S-6D (service in 6 to 10 years, developer financed) to S-3D (service in 3 to 5 years, developer financed) for .97 acre at 23458 Three Notch Road California, MD. The property is described in a deed recorded among the Land Records of St. Mary's County in Book No. 4189, Page 251 and is designated as Tax Map 34, Grid 9, Parcel 157 in the 8th Election District. The property is located approximately 300 feet southeast of the most southerly intersection of Mervell Dean Road and Three Notch Road. The amendments are requested in anticipation of providing community water and sewer service for proposed commercial development.

CWSP #17-003, PELBS, LLC.
