

**MINUTES OF THE PLUMBING AND FUEL, GAS BOARD MEETING  
PATUXENT BUILDING MIDDLE CONFERENCE ROOM \* LEONARDTOWN, MARYLAND  
Wednesday, January 13, 2010**

**Call to Order**

The meeting was called to order by Chairman Bernie Taylor at 1:10 p.m. Members present were Charles Downs, Dwight Mason, Mike Sullivan, and Gerald Davis. Members excused were Daryl Calvano and David Shapiro. Jada Stuckert, Recording Secretary was also present.

**Old Business**

- **Update on Commission on the Environment Letter**

Chairman Taylor recommended reviewing three chapters per meeting in order to be done in 6 months at which time we can begin reviewing the "09" Natural Fuel Gas Code and the "08" Liquefied Petroleum Gas Code.

Chairman Taylor presented Gerald Davis with a plaque for his service as Chairman and time served on the Plumbing and Fuel Gas Board.
