From **January 16th to March 3rd, 2025**, all members of the community were invited to participate in **Community Engagement Window #1** (CEW #1). Residents, property and business owners, and community partners had the opportunity to share their thoughts and future vision for St. Mary's County by taking part in **12 Community Visioning Sessions** (10 in-person, 2 virtual). During the Visioning Sessions, which took place from January 16th to February 22nd, participants took part in small group discussions, completed a survey, and completed mapping activities. The same Visioning Activities were available online from February 3rd to March 3rd. This Dynamic Report shows how community members responded to all multiple-choice questions.

Support Small Businesses & Local Economy – Encourage local businesses that align with our rural lifestyle, such as farmers' markets, artisan shops, and family-friendly venues.

Improve Services Without Over-Urbanizing – Expand amenities like high-speed internet, grocery store variety, and healthcare access while keeping commercial development in designated areas.

If we take these steps now, we can ensure that future generations enjoy the same quiet, beautiful St. Mary's County we love—just with a few more opportunities and comforts to enhance our daily lives.








































