**A holder of a Sale and Delivery for Off Premise Consumption Permit must:**

- 1. Only sell a mixed drink or cocktail, as authorized by this permit and their license, for off premise consumption or delivery, if the beverage is purchased along with prepared food (no prepackaged snacks),**
- 2. Only sell or deliver to an individual who is at least 21 years of age and provides valid identification as proof of age,**
- 3. If the sale is for delivery (includes curbside), maintain a sales log, as required by the Alcohol Beverage Board of St. Mary’s County,**
- 4. For each mixed drink or cocktail authorized under this permit, be provided in the manufacturer’s original sealed container or in a container closed with a cap, cork, seal, or lid with no holes for straws or sipping,**
- 5. Not sell or deliver later than 11:00 PM**
- 6. Only deliver to the individual purchasing the alcoholic beverage,**
- 7. Be delivered only by the license holder(s) or the license holder’s employee, who is at least 21 years old and certified in an alcohol awareness program,**
- 8. Not deliver to another licensed premises or an address located outside of St. Mary’s County, and**
- 9. Limit the number of mixed drinks or cocktails to two (2), 12 oz (or less) per single transaction.**
