

#### Reasons for Restructuring...


- Routes 901, 906 and 907 contract is set to expire on October 31, 2013.

#### D.C. Map for All New Routes




## Route 610 – DC East

- Midday and later PM trip options on 620 route




### Route 620 – DC West

- Twelve round trips plus a midday and later evening sweeper trip.




# Route 630 – Existing 907

  620 and 650




## Route 640
