#### CIP PROJECTS

Nick Isom informed the Board that \$300,000 was approved in the FY2020 St. Mary's County CIP Budget for the purpose of completing the bunker project (\$90,000) and nine (9) holes of the cart path project (\$210,000).

Discussion also took place regarding the need for renovation of the 15<sup>th</sup> fairway which will require a drainage project.

It was agreed that a Special Meeting may be called by the Board Chair in August once the cart path bid quote and a cost estimate for the fairway drainage are received. If needed, the meeting will be for the purpose of receiving Board input regarding the allocation of the \$300,000 towards the bunker, fairway drainage and cart path projects.

Mr. Shepherd indicated that the Welcome Center concept continues to move forward and that any program and equipment costs will be addressed in the fall budget WSGC budget process.
