and acl	W, THEREFORE, in consideration of the sum of One Dollars (\$1 .00) and other good d valuable consideration, the receipt and sufficiency of which is hereby knowledged, the Owner hereby imposes the following covenants upon lots within Subdivision		
wh:	ich adjoin access right-of-way.		
1.	Each of said lot owners in Subdivision shall annually contribute to a road maintenance fund an amount equal to% of the total cost for the repair and maintenance of said right-of-way. The fund shall be established with an initial contribution of \$ for each lot in the subdivision at the time each of said lots is conveyed by the Owner herein. Annual contributions shall be due on the day of of each year thereafter.		
2.	The road maintenance fund shall be collected and managed by an association of lot owners, each subdivision lot having one (1) vote in the affairs of the association. The lot owners agree to form the association on or before, 19, and any actions taken by the association shall be by majority vote of the total vote in the association, including the adoption of bylaws and the election of officers. The association president shall give at least days prior written notice to each lot owner of the date, time and location of the association's meetings.		
3.	The association president shall be responsible for carrying on the business of the association and shall be authorized to negotiate checks on its behalf and initiate legal actions of behalf of the association for the collection of amounts due to the road maintenance fund.		
4.	. Upon any default in the payment of the annual contribution to the road maintenance fund, any one or more of the lot owners, or the association formed for the collection and management of the road maintenance fund, shall have the right to take legal action in order to collect any amounts due from a defaulting lot owner To this end, each lot owner shall pay such amounts so assessed for the repair and maintenance of said right-of-way, and to pay to any other lot owner or the association reasonable attorney's fees and court costs for any suit successfully brought against them for the collection of such monies.		
5.	This Agreement shall be binding on and benefit the parties hereto and their personal representatives heirs and assigns, including any subsequent owners of the aforesaid lots in Subdivision, and shall run with and bind such lots.
