

School Age Care Program

Registration is for the School Age Care Programs for 2024-25 school year will open on Friday, March 1, 2024. Online registration is open for the current school year. For more information, please contact 301-475-4200 ext. 1800. If you register after July 1, 2024 for the next school year, you will need to do so in-person at the Recreation & Parks main office at 23150 Leonard Hall Dr, Leonardtown (Patuxent Building).



The objectives of the School Age Care Programs include providing a safe, fun program for school aged children that provides opportunities for social interaction among peer groups; improving physical, emotional, and social well-being; developing leadership skills; and expanding existing interests, skills, and abilities through engaging, developmentally appropriate activities. Our programs are licensed through the Maryland State Department of Education Office of Childcare and have received a Level 1 rating from the Maryland EXCELS quality assurance program.

SAC is a fun and safe place for your child immediately prior to and following school hours. Children are offered a variety of hands-on activities and opportunities to explore various recreational experiences for personal growth. The program allows for group games, creative arts, theme specific activities, and outdoor recreation. New in the 2022-23 school year are Mindworks™ curriculum programs (Exploratorium, Dream Teams, Steam Maker, Passport, and Construction Zone) and The Walking Classroom™. Snacks are provided each morning and afternoon in accordance with state-mandated nutrition guidelines. Registration is \$60 per family each year.

Hollywood Recreation Center provides School Age Care for children attending Hollywood Elementary School and serves as the location for our Teen Afterschool Program (TASP). TASP serves students from Spring Ridge, Esperanza, and Leonardtown Middle Schools. Students are bused from their school to the Hollywood Recreation Center. St. Mary’s County Public Schools provides bus transportation for both the School Age Care program for Hollywood Elementary School and the TASP.

Registration & Package Options

Registration for School Age Care programs can be completed in-person at the main administrative office in Leonardtown. Registration requires a one-time fee of \$55 per family. This fee secures your spot and is non-refundable. Additional paperwork is required, and staff will walk you through the process. REGISTER ONLINE

When registering prior to August 9, 2024 (August 2, 2024, for Chesapeake Public Charter School), you will only pay the \$60 registration fee at the time of registration. Once registered, you will be billed each month beginning in August through April. If registering on or after August 10th, you will need to pay the registration fee and the first month’s tuition. Staff will explain the required payments. **All participants are subject to a 2-week wait prior to attending the program and students enrolling after the first day of school will start on a Monday.** Students starting in the middle of a month will have their tuition prorated on a weekly basis.
