Chairman Report:

- Welcome to LCDR Steve Palmer, new AAB member in new ad hoc, ex-officio AAB position

- Brief by Pittsburgh Institute of Aeronautics (PIA) regarding maintenance school was well attended by local business community on 9/22/21. Key takeaway is it takes a lot of community support to establish a new maintenance school.

- White paper sent to AAB members regarding small airports and Advanced Air Mobility (AAM). Might be an opportunity for 2W6.

- John Deatrick is retiring 12/31/21. His leadership of DPWT is greatly appreciated, he's been a huge advocate for the airport.

DPWT Report (Swint, Airport Manager):

- NOTAM published to close runway on 30 Sep for one day 0800-1600, will reopen with 500 ft displaced threshold. Close again in 60 days to reopen the threshold but runway will remain the same length until extension completed.

- Construction on runway extension is behind schedule 1-3 months

- Terminal construction on schedule to be complete by 12/18/21. Navy Annapolis Flight Center will be moving into new space approximately 1/1/22.

- New hire in place. David Gately started today as airport tech. No background in aviation but strong in handyman functions which are described in the job description.


Automated Dependent Surveillance – Rebroadcast vs.

Traffic Information Services – Broadcast

Automated Dependent Surveillance - Rebroadcast (ADS-R)

ADS-R is a service that relays ADS-B information transmitted by an aircraft using one link technology to aircraft within the proximity of active users of an incompatible link technology. The high-level data flows supporting ADS-R are illustrated in the figure below.


The control station infrastructure monitors ADS-B transmissions by active ADS-B equipped aircraft and continuously monitors the presence of proximate aircraft with incompatible link technologies (i.e., UAT and 1090ES). When such aircraft are in proximity of each other, the control station infrastructure instructs ground radio stations within range of both aircraft to rebroadcast surveillance information received on one link frequency to aircraft on the other link frequency.



Traffic Information Services – Broadcast (TIS-B)

TIS-B is a service that provides ADS-B equipped aircraft with surveillance information for aircraft that are not ADS-B equipped. The high-level data flows supporting TIS-B are illustrated in the figure below. The control station receives this air traffic information from non-ADS-B surveillance systems, including FAA/ DoD secondary surveillance radar, ASDE-X, and multilateration systems. The non-ADS-B surveillance information from multiple systems is then fused with ADS-B and correlated to defined tracks.

The system uses this information to transmit TIS-B targets for non-ADS-B-equipped aircraft that are in proximity to active ADS-B-IN users. The TIS-B Service is complementary but orthogonal to the ADS-R service and ADS-B air-to-air such that ADS-B-IN users will see a complete picture of the nearby targets without redundancy.
