Solid waste removal completed. Test pitting indicated a little more excavation will be required. Notice to Proceed for Phase 3 runway was issued 4/13/24. Work will start 4/27/24 beginning with the demolition of taxiway pavement. A NOTAM will be issued for the closure of the taxiway.

The Pavement Management Study completed the runway test plugs and Management Plan will be complete by August.

The construction proposal for updating the front of the terminal has been completed. Revised quotes are in review.

The MMA inspection of the airport was completed 17 April. Noted the issue of equipment markings at the construction area. Also noted was the antiquated AWOS system at the airport. The oldest in all of Maryland.

Funding request for AWOS update is in the planned budget for 2025. This should be high priority.

The Airport Manager will be attending Regional Airport meeting 13 and 14 June.

The Airport Manager noted that there are now 245 aircraft base at 2W6.
