Airport Advisory Board Minutes –06/24/2024

Meeting Start: 6:00 PM

Members Present: Hill (Chair), Lightstone (Vice Chair), Osborne, Fuller, Skrabacz, Zaorski, Ex-Officio – Chief Galinski, NAS Pax River Air Operations, Doug Dickens (Aviation Safety Officer, Naval Test Wing Atlantic)

Others Present: Allison Swint (DPWT), Jim Gotsch (DPWT), Katherine Stormont (DED), Dave Stanton (RCS Services), Tony Capozzi (DPE), Ken Reed, Pat Weaver, Jeremy DeBons (Ready 9), Tim Wilson and John Schultz

Chairman's Remarks:

Noted a Quorum were present.

Suggested that in the future the board consider developing position documents to provide support for areas of investment related to the airport.

Noted that there is funding for a new AWOS in the 2025 budget. Monitor activity as this should be a high priority.

Recommended a meeting with Department of Economic Development (DED) and Department of Public Works and Transportation (DPWT) to discuss establishment of a Vertiport at 2W6. Side comments noted that SMECO has the capability to install charging outlets that would support EVTOL, Drones and Electric aircraft.

DPWT Report: Jim Gotsch DPWT, Allison Swint DPWT/Airport Manager

Moving the taxiway is underway. FAA funding. Wet soil requires undercut and fill with stone.

Runway – all trash has been removed. Runway extension underway and will also require undercut and fill with stone. The Runway extension will be completed by the end of the year!

The Pavement Management Study completed the runway test plugs and Management Plan draft has been received. Limited depth of asphalt in the runway. More info to follow. Planning for replacement of the runway in 2027 or 2028, which will require closure of the airport for up to 90-100 days.

The Master Plan for the airport is the next project for AECOM.

The airport runway will be closed from 7 am to 7 pm on 26 June for the ASUVI competition. NOTAM has been published.



The Airport Manager attended the Regional Airport meeting 13 and 14 June. Very good meeting and exchange. 2W6 is now the largest GA airport in Maryland with 245 based aircraft. It is recommended that for the next one that more members from the 2W6 community attend.

The Airport Manager asked if the Navy would be willing to schedule the Navy / Airport exchange that normally takes place in May, for September this year. Also discussed is the potential for scheduling another Rusty Pilots seminar at 2W6. The last one was held in 2020. AOPA runs these events.

FBO Report – None from RCS. The review of the hangars for compliant usage is being coordinated with the Airport Manager. Some progress noted.

Pax Air Ops Report: --Chief Galinski attended representing LCDR Hughes.

AeroPark Update: Katherine Stormont stated there was no update to the terminal proposal.

Old Business:
