The meeting of the Alcohol Beverage Board of St. Mary's County was held on Thursday, March 12, 2020 at 1:00 PM in the County Commissioners Conference Room, Chesapeake Building, Leonardtown, Maryland.

Chairman Denietolis called the meeting to order at 1:00 pm and introduced the Board and staff.

Approval of minutes.

Member Kohl moved to approve the February 13, 2020 minutes. Motion was seconded by Member Willenborg. Motion carried.

Mr. Lupo explained to the Board that Sweet Bay would like to allow patrons to bring in their own wine, that they do not serve, and this would require a corkage privilege. Member Kohl moved to approve the corkage privilege. Motion was seconded by Vice-Chair Trossbach. Motion carried.
