Member Kohl moved to approve the agenda. Motion was seconded by Member Hill. Motion carried.

APPROVAL OF MEETING MINUTES

OLD BUSINESS

• Extension of Conditional Approvals

Old Town Pub - John MacDonald Jr., Joseph Drury, Jason Burroughs- Requesting 90-day extension of conditional approval for outdoor seating

John MacDonald appeared before the Board and was sworn in. Mr. MacDonald presented a letter from the other licensees giving him permission to speak on their behalf. Mr.

MacDonald explained that the construction of his outdoor seating has been completed but he hasn't gotten all the final approvals. Member Kohl made a motion to approve a 90day conditional approval pending the Fire Marshal and Use and Occupancy. The motion was seconded by Member Hill. Motion carried.
