FY 23 Budget discussion

Mrs. Hildebrand explained to the Board that she would be asking for a \$35,000.00 increase in the budget which will cover costs for a 5-year lease (\$8,100.00 annually) to replace the inspectors vehicle. There are no longer any loner cars that the County has available for the ABB to use as we have had in the past so we will be forced to lease a vehicle for the inspector to drive. This lease would not start until FY 23. Mrs. Hildebrand stated to the Board that she had spoken to Mr. Beaver regarding the inquiry and the minutes that were presented but the Board can always request a transcript of the inquiry if they so desire.
