Joe Kurley from the Rex came before the Board to represent the SMLBA to answer questions referring to whether the Board should keep the privilege of the New Years Eve permit. Mr. Kurley's response from the SMLBA was to keep the privilege even though there was not much participation in the event. Mr. Kurley also suggested for a reward program for establishments who stopped an underage sale during a compliance check. Mr. Kurley explained that his establishment is preparing to set up a plan for customers to have a designated driver to get them home at the end of the night.

## COMMUNITY ALCOHOL COALITION

Chris Shea stated there was not much new at the CAC. Mr. Shea explained that the marijuana legislation would be up for vote so that will be the topic of discussion at upcoming meetings. Mr. Shea discussed some funding options that may help with incentive programs for retailers.
