Extension of Conditional Approvals

The Brass Tap Craft Beer Bar & Kitchen – Josephine Snavely, Michael Snavely, and Candace Snavely - Requesting 90-day extension of conditional approval.

Josephine Snavely, Michael Snavely and Candace Snavely appeared before the Board and were sworn in. Mr. Snavely explained to the Board that they have finalized the lease with the landlord and are moving forward to obtain their permits and other necessary obligations to begin the building of the restaurant.
