The meeting of the Alcohol Beverage Board of St. Mary's County was held on Thursday, December 14, 2023, at 1:00 PM in the County Commissioners Conference Room, Chesapeake Building, Leonardtown, Maryland.

Vice-Chair Watts moved to approve the minutes for November 9, 2023 and was seconded by Member Kohl. Motion carried.

## **OLD BUSINESS**

• Extension of Conditional Approvals:

**The Slice House** - Maegyne Held- Requesting 60-day extension of conditional approval for interior expansion.

Maegyne Held appeared before the Board and was sworn in. Mrs. Held explained that they are waiting for the parts for the new oven. Mrs. Held is requesting to change the original request from a 60-day to a 90-day approval. Member Kohl moved to approve the 60-day to a 90-day extension and was seconded by Member Hill. Motion carried.

**Social Coffeehouse and Speakeasy -** Requesting 90-day extension of conditional approval for location transfer.

Member Kohl made a motion for a \$250.00 fine and was seconded by Vice-Chair Watts. Vote was 3:1. Vice -Chair Watts opposed. Motion carried.

Sale of alcoholic beverages to a person under the age of twenty-one (21) in violation of §6-304 of the Alcoholic Beverages Article of the Annotated Code of Maryland and §5.04(j) of the Rules and Regulations of the Alcohol Beverage Board of St. Mary's County.

Brian Adkins appeared before the Board and was sworn in and was accompanied by his attorney Joseph Capristo. Mr. Adkins admitted that the violation did occur. Vice-Chair Watts made a motion for a \$1000.00 fine, \$500.00 from the previous violation, 3-day suspension and RAST training and was seconded by Member Hill. Motion carried. The 3-day suspension will start on December 15,2023 and end on December 18,2023.

• FY25 Budget Review

Mrs. Hildebrand explained to the Board that she would like to increase the Inspector's hours. She presented two options: 1. increasing from 20 hours to 30 hours or 2. Increasing to full time. Mrs. Hildebrand stated that the AEC's costs had decreased and would compensate for the increase of either option. She explained that the current part-time status of the Inspector position does not allow for the legally required number of inspections and that the requirements of the job support a full-time position. The Board supported a full-time position and requested Mrs. Hildebrand to include this in the budget.
