# C. St. Mary's County Museum Division Update

#### **NOVEMBER**

- The Benjamin Hance Historic Marker Dedication Ceremony was held November 1, 2021 at the Old Jail Museum and was a huge success
- The Holiday Open House at Piney Point was successful, with attendance better than any prior year (141 over 4 hours)
- · The Old Jail Museum was open for Leonardtown's Christmas on the Square with good attendance
- Wildlife Photography Class was held at St. Clement's Island Museum (14 people attended)
- April Havens, the Piney Point Site Manager, retired after 15 years

## **DECEMBER**

- The December-long Christmas exhibits were as popular as ever at St. Clement's Island Museum and Piney Point Lighthouse Museum
- The Holiday Open House at St. Clement's Island Museum was successful, with attendance of 83 over 4 hours

- The house next door to St. Clement's Island Museum is now in the hands of Maryland Department of Natural Resources (DNR) and they are working on the lease
- Museum Division can use it with case-by-case permissions
- St. Mary's County Department of Public Works (DPW) has done an exterior inspection and it is in good repair
- DNR prefers we keep it at this time rather than razing it and replacing for other uses

### D. Coordination of County Museums & Historic Sites

- The group is working on a pass that could be given to B&B guests, paid for the B&B owners, that would allow access to all museums and historic sites in St. Mary's County. A joint event between Sotterley and the Museums is being planned for the Blessings of the Fleet weekend. Events for Moll Dyer Day and An Underground Railroad Commemoration Day are being coordinated. The different entities are trying to eliminate event schedule conflicts.
- E. Friends of St. Clement's Island & Piney Point Museums and Potomac Jazz & Seafood Festival Update
  - Plans continue for an expanded and exciting event with gifted musicians across 3 days. See www.PotomacJazzAndSeafoodFestival.com for continual updates.

# F. Department of Recreation & Parks Update

- Arthur Shepherd, Director, reports that the Department is nearly done with Accreditation (CAPRA) process, and is confident they will be successful.

  - Maryland Day is Friday, March 25, 2022 at St. Clement's Island Museum with Mass on the island at 11:00 a.m. and the ceremony is at 2:00 p.m. Museum is open to the public for free all day from 10:00 a.m. to 5:00 p.m. with free water taxi rides until 2:00 p.m. and food trucks on site
  - A presentation on the Black Diamond Tragedy during the American Civil War is upcoming
  - Dinner and Cruise Series 2022 schedule is now posted
  - Many guest lectures are scheduled at the museums
  - Retrofest on the Potomac at Piney Point Lighthouse Museum has been moved to June to coincide with antique boat races
