A. Museum Division & Friends Updates

- November: Holiday Open House at Piney Point was well attended in spite of the weather (106; 141 in 2021); Trustees signed the 5-year Strategic Plan; Division continued to staff the USCT Interpretive Center on Wednesdays from 10am to 2pm; Two members of the Division attended the MD Tourism and Travel Summit; Two members of the Division attended the Governor's Grants Office Workshop
- December: Seventeen Men exhibit at USCT Interpretive Center closed (total visitation 143; shipped to PA); Board of Trustees had 3 members reappointed and one new member appointed; Museums were closed on Christmas Eve and Christmas Day (Piney Point was closed on 12/23 and 12/27 due to ice and lack of heat); SCIM Holiday Open House went well (2022 = 150; 2021 = 83); The Museum Division received a SOMD Heritage Area grant in support of the renovations to the U-1105 exhibit at Piney Point
- The Southern Maryland National Heritage Area passed the US Congress on 12/27/2022. President Biden signed it into law, so now all our museums are included in this development. Much publicity will be generated this year, and the event will be highlighted at Maryland Day
- Awarded a Maryland Heritage Area grant for work at Piney Point; much work is being done on the U-Boat display at Piney Point, including an effort to establish a permanent camera on the submarine itself.
- On January 31st, Board volunteers are being recognized by the county at 8:30 a.m.. Attendance is requested.

B. St. Clement's Island Museum Building Plans Updates
