- B. St. Clement's Island Museum Building Plans Updates
 - Plans have been approved grading permits completed, looking to go to bid in the next few months with construction to begin in 2025 and to last 12 months
- C. St. Mary's County Department of Recreation & Parks Update
 - The current water taxi lost its engine and is old; Karen got a federal grant for new, larger accessible water taxi, with no match required. The bid process has been complicated but is complete. The new taxi should be ready by 2025, with the old one serving until then. The new one should be approved to go further into the Potomac, rather than staying in the St. Clement's channel
 - Another vessel that will be multipurpose is being funded at \$700,000 with the St. Clement's Hundred that will be
 able to carry people but also large equipment to the Island. It will allow more people to get to and from the Island,
 rather than leasing a vessel on high traffic days
 - The playground at Lancaster Park has been completed
 - The Arts Council has selected three finalists for the mural at the Passive Park
 - The \$10,000 grant planning with the Arts Council for developing art in the parks has been completed, with projects to be started

 - Will be submitted on Friday the 13, with this Board's recently-completed letter of support included, especially for a permanent exhibition honoring African-American contributions to the county
