4. New Business

A. Building Code Board of Appeals Permit 22-1134, owner St. Mary's County Government, Recreation and Parks is seeking a reconsideration of the failed inspection at Chaptico Park, 26600 Budd's Creek Road Mechanicsville, MD 20659. This inspection per MDIA did not meet the 2018 IECC Reference to email from contractor regarding low energy building should qualify. Article (C402.1.1 (2) building conditioned. And Article C402.5 air leakage (mandatory). This is the third restroom built to the same specifications in the last two years, the first two gained inspection approval (Dorsey Park and Lexington Manor Passive Park).

John Houser, Assistant County Attorney. St Mary's County Government presentation to the Building Code Board of Appeals members.

Decision per John Houser, Assistant County Attorney, St. Mary's County Government: Per IECC 402.1.1, Issue building permit on the condition the temperature not be set above above 55 degrees Fahrenheit unless structure is brought to compliance with requirements of IECC C.402. Going forward Recreation and Parks will meet the efficiency requirements on any future construction. Permit 22-1134 is administratively resolved no action is needed by the Building Code Board of Appeals.

B. Permit 22-1136 Gary McQuay is seeking a reconsideration of the failed inspection at 24395 FWD Dr. Hollywood, MD 20636. The deck was built with the IRC 2009 building code.

Gary McQuay presentation of the stair riser for permit 22-1136. Applicant stated deck stairs were built according to the old guidance still available on the County's website. LUGM confirmed the guidance was present at the time but has since been removed.

Decision: Approve the requested modification to the 2018 IRC Residential Code, Section R311.7.5.1 Riser Height, to reduce the minimum required riser height from 7.75 max height inches to 8.25 max height inches for the new deck staircase Permit Number 22-1134 24395 FWD Dr. Hollywood, MD 20636.

Motion: In the matter of permit RESADD 22-1136 on and of appeal from the Department of Land Use and Growth Management determination the demands of the IRC Section R311.7.5.1 were not satisfied, that the Building Code Board of Appeals finds and concludes applicant has presented an alternative that is as good or better as the codes requirements 24395 FWD Dr. Hollywood, MD 20636.
