Mr. Geo. A. Weschler interviewed the Board with reference to right of way deed for road leading from Pearson-Hermanville State Road towards the Bay, and into the properties of the Messrs Weschler, Mr. Sam Young et al. Board agreed to accept a 30 ft. right of way for this road.

Susie Brown, Leonardtown, and Sam Taylor Park Hall applied for G.P.A. Pending futher information no action was taken. *on Susie Brown Sam Taylor allowed \$12.00, only 1 Payment.*

Clerk directed to write Rev. Horace B. McKenna, Peter Fenwick, Capt. Ed. Thomas, right of way deeds would be accepted by the Commissioners for road into Cardinal Gibbons Inst, for road between Ridge and Newtown in the 1st. Dist, and for road into the property of the Sisters of Holy Cross, St. Geo. Island.

Mr. Joe Chaney District Engineer of State Roads Commission visited the Board and discussed road matters for the coming year.

The Clerk was directed to write the State Roads Commission to determine if the County Road forces could grade and gravel the Beauvue-Valley Lee Road and this cost be deducted from the \$23,397.00 fund administered by the State Roads Commission, and futher to determine if the Bridge could be built by separate contract.
