Mr. Briscoe representing Mr. Dallas B. Hays, requested the Board to continue the Fresh Pond Neck Road to the the Bay. Mr. Webb requested to make a report on this road.

Board accepted Right of Way Deed from Albert L. Fish et al for a section of road leading from the Pearson -Hermanville road to the Bay, 8th Dist.

Mr. J. O. Burnham interviewed the Board with reference to the Blackstone Road 6th Dist, and Mr. C. P. Speith requested the Board to provide him an outlet to the Leonardtown- Compton State Road. In the case of Mr. Burnham recommendations had previously been made, and in the case of Mr. Speith, Board promised to look into the matter.

Mr. Baldwin, Architect, visited the Board and discussed plans for a new jail.

Board authorized the correcting of the Jno. L. Biscoe- Jno. Biscoe title. This property was sold to Ann Dyson. Mr. King instructed to proceed through the Equity Court to calrify the matter.
