Minutes of preceding meetings read and approved.

The Board decided to confer with the State Roads Commission in their office in Baltimore on Wednesday Jan,22,1941.

The following resolution was presented and unanimously adopted by the Board:

Resolved by the Board of County Commissioners of St.Mary's County, a Body Corporate and Politic,in meeting assembled: That in conformity with the power and authority vested in it under Chapter 140 of the acts of the General Assembly of Maryland,1939 session,do hereby appropriate for the 1940-1941 school year the sum of Ten thousand dollars(\$10,000.00) for the transportation to and from school of children attending schools in St.Mary's County not receiving State aid, and do hereby order and direct the Clerk to the said Board of County Commissioners to issue 1941 County Scrip on the faith and credit of said County, to the amount of \$10,000.00)ten thousand dollars, and to pay over,out of said sum, to the Director of each of the following schools in said County not receiving State aid,Namely: Holy Angels school, Avenue,Md.;66 Bus miles; Immaculate Conception school,Mechanicsville,Md.,72 Bus miles;StMichaels school,Ridge ,Md.,132 Bus miles; St.PeterClaver school,Ridge ,Md,100 Bus miles; Little Flower school,Great Mills,Md.,200 miles; St.John school, Hollywood,Md.,136 miles;Our Lady school,Beauvue,Md.,76 miles; St.Joseph school,Morganza,Md.,78 miles; Sacred Heart school,Bushwood,Md.,80 miles, the amount to each of these schools to be proportioned and based, for the 1940-1941 school year, on the mileage covered by their respective Busses as given above.

L.E.Trossback and Jno.F.Bradburn again appeared before the Board and urged that the County accept into the County road system for maintenance the Trossback road,1st Dist. Mr Bradburn also complained that his land was being flooded because of improper drainage of the St.Jerome's Neck County road. Mr.Thompson asked to get in touch with Commissioner Combs and go with him to investigate the condition complained of by Mr.Bradburn.

The Board decided to reccommend to the State Roads Commission that the unimproved portion of the Mill Hill road,8th Dist.be made a W.P.A. project for improvement.

The Board decided to accept into the County road system for maintenance .4 mile of the 3 notch point road, from the 3 Notch Road towards the Chesapeake Bay,8th Dist., as soon as the interested parties can secure the right-of-way.

G.H.Chappelear asked the Board to accept into the County road system, for maintenance, road running to Potomac Beach, about .4 mile,3rd Dist. Mr.Thompson asked to report and to contact Mr.Chappelear.

Mr.Geo R.Lawrence asked the Board to widen and improve a part of the Dynard-Bushwood road, on the Bushwood end,about 1 mile,7th Dist. Mr.Thompson asked to report and to contact Mr.Lawrence.
