Minutes of preceding meeting read and approved.

Walter E. Long asked the Board to recommend to the S.R.C. an increase in the pay of State Road workers.

On the certificates of Dr. Robert V. Fuchs and Dr. P. J. Bean the Board committed Edmund Hammett to Spring Grove State Hospital, as of Feb, 19, 1942

Dr. Robert R. Riley, Dr. Eugene C. Peck and Mr. Walter H. Kirkman appeared before the Board in the interest of having a laboratory for St. Mary's Hospital provided for by the Board. It was stated that the State would train and supervise, from the State Laboratory at La Plata, Md., a Technician to operate the Laboratory. Mr. Kirkman estimated the cost of equipment at \$550.00. The annual cost of supplies at \$200.00 to \$300.00 and the salary of the Technician. They said the Hospital would provide quarters. Board took the matter under advisement.

Mr. A. F. King, Director, C.D. asked the Board to authorize the installation of four telephones (to be placed in locked cabinets) in a room at the Leonardtown fire house for a control center for the County. The Board authorized Mr. King to have the phones installed. Mr. King invited the Board to attend a meeting of C.D. workers to be held at Dukes at 7.30 P.M. March 5th.

The Board adopted the following resolution:

Resolved, that Governor Herbert R. O'Connor be and he is hereby requested to advocate and support at the next session of the General Assembly of Maryland such appropriate action as may be necessary to do away with all State taxes on real estate and tangible personal property, to become effective at as early a date as maybe found possible, and;

Be it further resolved, that a copy of this resolution be sent to Governor O'Connor and also that copies be furnished each of the County Papers.

The Clerk was instructed to Notify Hon. Maury Maverick, Chief, Governmental Requirements Branch, War Production Board that this Board would attend a meeting of County Commissioners from all Coast States to be held in Washington, D.C. at 10.00 A.M. March 9th & 10th 1942.

Due to attendance at the above meeting the Board postponed the next regular meeting from March 10th to Wednesday March, 11th.

Judge Miles and Judge Wible of the Orphans Court asked the Board to have a telephone installed in the Orphans Court room.

The Board appointed Mattingly Johnson, Harvey Hilton, ~~Clem Fennison~~ <sup>Harry C. Davis</sup> and ~~James Power~~ <sup>Donald Robinson</sup> assessors for the new assessment to be held this year.
