Minutes of preceding meeting read and approved.

Miss L.M. Dent, Superintendent of Schools discussed the 1942 school levy with the board. Miss Dent said the higher pay being offered by the war industries, and Government work was threatening to take away our Teachers, and she asked the Board to levy \$4000.00 to enable her to pay a bonus to the Teachers, and to levy \$800.00 for an artesian well at Margaret Brent High School, and for \$200.00 for interest on debt. The Board refused to include any of the above items in the levy.

The Clerk was instructed to write the Legislative Council and urge that the State make some provision for increased compensation for the Teachers during the War Emergency.

Mr. A.F. King, Director, Civilian Defense submitted a sample indentification card to be issued to those entitled to be on the road during black outs or air raids. Board approved the design of the card.

On the certificates of Dr. Arthur Hebb and Dr. Robert T. Fuchs the Board committed Eugene A. Fenwick to Crownsville State Hospital, as of March 21, 1942.

Mr. Muller from the State Tax Commission met with the Board and instructed the County assessors in their work for the new assessment.
