Minutes of preceding meeting read and approved:

Miss Lettie M. Dent, Superintendent of Schools requested the Board to provide About \$200.00 for typewriters and supplies in order that the public schools could start ~~giving~~ business classes. Miss Dent said the Federal Government would provide funds to pay the teachers for these classes. The Board requested Miss Dent to supply more specific information on the amount of money needed.

The Board decided to start reviewing the new assessments on Friday May, 1st next at 10.00 A.M.

The Board fixed the salary of Jno. W. Wathen, J.P. at \$50.00 per year, and instructed the Clerk to pay the difference (\$30.00) for this year from the C.G.F., only \$20.00 having been levied for his salary this year.

The Board appointed Jos. C. Taylor tax assessor in place of Donavan Bohanan, resigned, as of April, 20, 1942.

George Smith requested the Board to accept into the County road system the road from the State road to Point Lookout Hotel, about 250 yds, 1st Dist. Mr. Thompson asked to report and to contact Mr. Smith.

The Clerk was instructed to write the State Roads Com. and recommend acceptance into the County road system, for maintenance, the Breezy Point road, 7th Dist.; and to Joseph Chaney, District Engineer, and recommend that the County road laborers be paid 40¢ per hour the same as the State road laborers are paid.
