Minutes of preceding meeting read and approved.

The Board selected Paul J. Bailey and Ninian P. Barber as members of the St. Mary's County Welfare Board, to serve until May 31st, 1950, but failed to designate the County Commissioner who will serve as a member of the Welfare Board until May 31, 1945.

Miss L. M. Dent, Supt. of Schools, appeared before the Board and asked for \$5260.00 to make good a shortage of funds for teachers salaries caused by the refusal of the State to allow any State funds to be used to pay teachers whenever any school had failed to maintain the specified average attendance required by the State.

Miss Dent also stated that the State was holding up the payment of \$18,000.00 of the equilization fund now due, until they were assured that this \$5260.00 shortage would be taken care of by the County. No action taken by the Board.

Mr. Thompson asked to report on advisability of accepting for maintenance about one-half mile of Fresh Pond Neck road running to Point Look In, which had been asked for by Congressman Sasser for S. K. Hushing. 1st Dist.
