Special Meeting.

Board met on November 17, with Frs Kavanaugh, Devany, McBride and Mr. Jos. Hancock relative to school bus route to St. Jos. Sch. Mr. Hancock carries 98 children, Loveville-Oraveille Rt \$2548.80
Fr. Kavanaugh " 68 " Clements, etc 1771.20
Increase allowed for extra no. and mileage 720.00
Back payments to be adjusted as driver has been making additional trip in order to carry children safely.

BOARD OF EDUCATION - Messrs. J. Claude Johnson, Geo. Thomas, Mrs. Gardiner and Miss Lettie M. Dent appeared relative to County Pub Sch.

1-Requests for definite steps to be taken in re; acquiring High School at Grt. Mills built by FPHA- 6 counties have already held meeting in Sen. Tydings office concerning this matter. Fed. Govt. desires dispose of buildings. Mr. Briscoe advises nothing be done, as no other county has purchased buildings. Mr. Brooks of FPHA thinks offer of not less than 20% of cost should be made to govt. School operates under a lease than runs for 6 mos. after Emergency expires but Emergency Expiration has not been declared. County has already paid for repairs to roof and furniture etc. Mr. Briscoe suggests matter be handled similar to jail. Miss Dent requested to ascertain what other counties are doing in matter.

2- Carvel Hts. Schl. overcrowded. small lot, poor bldg at Jarboesville, no room for expansion. Miss Dent talked with Comm. Minter re Administration Bldg at NATS, he reports Navy will retain that but suggests she look into the Dormitory Bldg which could be utilized? Should make inquiry thru Mr. Flanagan of Lex Park. If Miss Dent feels building could be remodelled for school use, she will report same to Board, Briscoe or King.

3- Bldg. Program.

Board of Education has insufficient room for working quarters. Mr. King and Mr. Bailey interviewed Judge Loker relative to using general Court room. Judge Loker very unwilling. Windows in Miss Dent's room need attention. Board suggested storm windows for same.

4- Gen. Building program.

Program suggested last January, erection of (1) w and (1) col bldg., Upper part of County needs new white school. Flooring in school room very bad. Capt. Matt Bailey suggested using masonite for floors. Miss Dent to ascertain where she can secure same. Dr. Pullen desires confer with County Comm. in re building program.

5- Transporting col. children to St. Jos.

Matter of using Pub Sch. bus for transporting 19 col children to St. Jos. Par. Schl considered. Mr. Briscoe read law Acts 1941 Ch 609
Sec 202 C-D-E-1943

Pub. Sch. bus leaves for children to upper part of county above St. Jos. starts at pt 1, passes 2-3 and picks up it's regular Pub sch children at pt. 4; since bus is empty when it passes 2 where 19 col children are waiting for bus, and would leave bus at pt 3, before other children board same, Comm request permission for children to ride on empty bus. Returning from school, Pub Sch bus would carryt it's regular 1st load

to pt 4, then returning pick up Par sch. children at pt 3- unload them at pt 2, and proceed to it's second regular bus load at pt 1. This would in nowise interfere with Pub Sch children schedule and bus would make 2 extra stops. Bd. Ed. seems to give this matter favorable consideration. Miss Dent requests she be given list with names and adresses of children etc.

Matter of Ejection on Dec 9, considered.

Mr. King suggested for sake of records and better understanding of requests placed before the Board that all be in writing for filing etc.
