Regular Meeting.

The Board met at 10 a.m. Capt. Matt R. Bailey and Mr. Frank Bailey present. In the absence of Mr. J.H.T. Driscoe, Mr. W.O.E. Sterling sat as attorney.

Roads.

Bushwood-Dynard-Hurry Delegation headed by Mr. Geo. L. Lawrecen requested something be done to surface this road which was built sometime ago.

Cedar Lane Road, residents request surfacing before summer months and dust set s in.

Clements-Chaptico- Mr. John Mattingly requests this road be surfaced used by 12 families and 2 school buses. Road less than 2 mi long. Road to be tarred $\frac{1}{2}$ mi at either end, the rest of the road is in bad shape.

Great Mills Road

Dangerous knoll prevents cars approaching from different directions seeing each other, frequent accidents result. Request made that SRC remove knoll between Spinning wheel and Texaco station. Letter to be addressed to the SRC to have this work done, 1 mi long full width of road. Man recently killed at this spot.

Ball field at Alms House.

Chas. Price owner of restaurant and ballfield near Calloway with Nace Ford protested the leasing of the ballground to the Businessmen. Nace Ford says he needs it for his crop- Chas. Price says he has a ballfield that he will lease for \$1.00 per year to any team, but feels if this ballfield is prepared it will take the cream of the crop of players, and business in other sections of the county will fall away due to lack of good ball teams playing etc. Commissioners still feel it will be a worthwhile project to have the ballfield on the Alms House property, adjoining Fair Grounds.

Patuxent Park

Mr. Rysticken appeared relative to requesting lights along the 3 Notch Rd, Great Mills Highway and to Trailer Camp 3 Notch Rd. 274 families pay about \$24,000 in taxes. no street lights, very dangerous for women and children at night. So. Md. Elec. Co-Op advise it will cost about \$400 per yr for lights- 1 fatality this yr on road due to no lights; Pepping Toms are in the park and lights would eliminate this. Section needs Public Dump. Garbage disposal big problem and handled by private contractor. Is interested in the CC&S disposal plant offered to the County feels it would be a good thing for the county to have for disposal for all sections of county in one central place
