Clerk was instructed to write to Sister Superior and ask that doors be opened for the children to go inside. Clerk phoned, and then wrote.

Stephen B. Foxwell was instructed, by letter, to install piles at the Public Wharf at River Springs- all labor and material to cost not over \$1244.00

Arrangements were made for Mr. Alvey, J. Ralph Abell and Wm. Sterling to go to the State Tax Office to ascertain if the new units at Lexington Park- Center Gardens could be taxed.

Letter was written Mr. Chaney of the SRC advising that the County Commissioners would reimburse the Md. SRC cost of constructing concrete curb and gutter along the proposed dual section of proposed reconstruction on Route 246, approximately one-half mile and will dedicate to the SRC, so far as their right, title and interest in the 20ft. on each side of the proposed route.

Mr. Thompson reported that the road to the new "ex. Park school was not completed but usable and will probably start the graveling next week.
