Bro. Lambert, CFX of Ryken High School came in about transportation for the pupils School will open Feb 18-Pauß Bell has contract to carry some of these children Will contact him to see what other transportation must be arranged for.

Air Conditioning bid had to be revamped, Mr. Smith of Smith's Inc., explained that he knew what had to be done and it would cost about 1% additional amount of his bid.

George Beitzell owns property to the rear of Jake Downs' place, .06 mi road with 3 houses on it- at present it is a dirt road. Mr. Guy and Mr. Thompson will check on the road and make their report at next meeting.

Salvatore Leonardo and Ercole Leonardo came in about Tall Timbers seawall- they were present when the bids were scheduled to be opened. Mr. S. Leonardo represents the Tall Timbers Citizens' Asso. He asked for plat of bends and jetties\_Mr. Thompson informed him there are none. He asked for a copy of the specifications which were mailed to him. He also asked to see the petitions which were signed by the property owners asking for this seawall- Mr. Leonardo feels that jetties 77-78 being beyond the line of improvement scheduled should not be charged to the other property owners; he was advised only the owner of the land bordring along this wall. Would have to pay for repair there.

David Gruber, re IBM Tax Bills says these bills can be prepared for the 1957 tax's and the Old system is now discarded New system will have assessment rolls and be much easier to handle than the old books and will contain the same information as the books Agreement was signed by Mr. Alvey -2 go to IBM, 1 to Mr. Truber

Mr. Willard, Charlotte Hall, re Dog Pound has changed his bid to \$12,000 per summer which the Board feels is more normal than his first price. He explained that it will be necessary to install certain equipment for putting dogs to sleep and keeping bodies until called for. Mr. Willard is anxious to start selling tags and he was told they are \$1.00 more than the usual charge if he has to go out to the homes of dog owners to sell these tags.

Mrs. Tilp toured the various rooms considering the color scheme- the painter requested a chart showing the different colirs to be used- they are Sprite green for all dark halls and windowless rooms, all panel doors and trim to be same color-flush doors are to be stained and all shutters in the Court Room to be cleaned, and restained-no varnish Rooms with windows to be malaga green, and ift wainscoating lading down stairs to Trial Magistrates room to be Parrot green- with Bone white above
